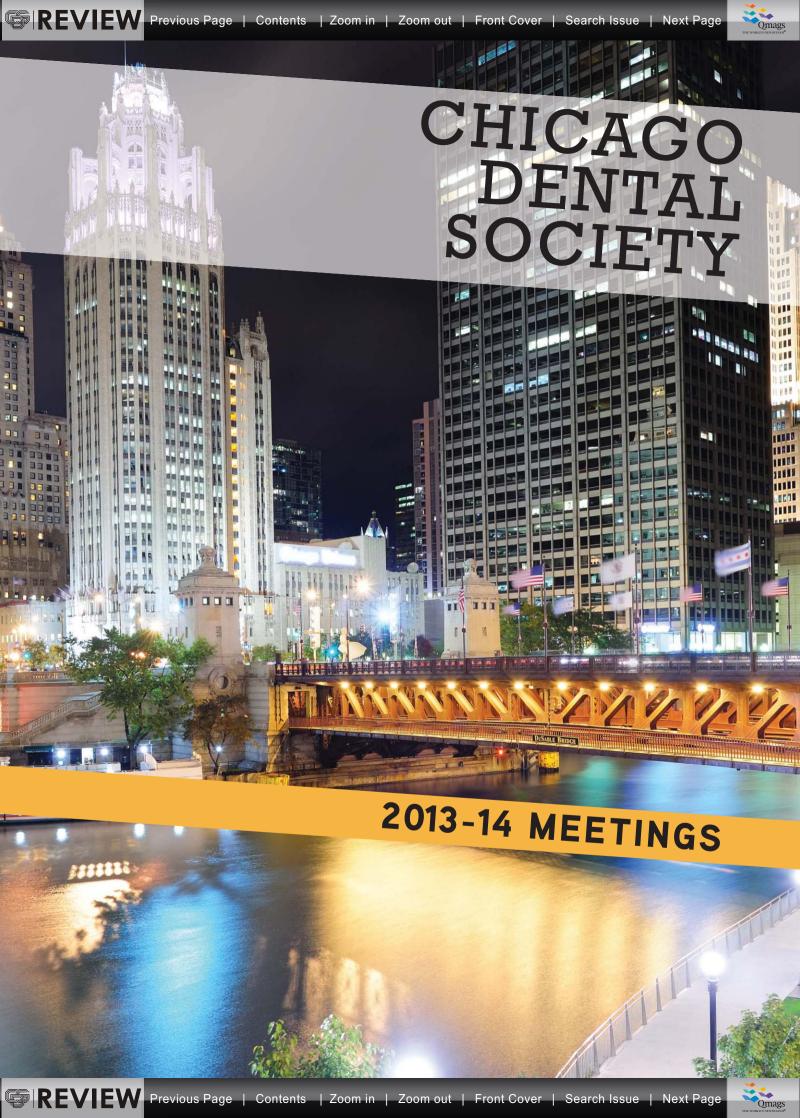

Minutes of the April 24 Regional Meeting

The Chicago Dental Society Regional Meeting convened April 24 at the Drury Lane Oak Brook, Oakbrook Terrace, with CDS President David Fulton Jr. presiding.

Dr. Fulton called the meeting to order at 9:05 a.m.

Attention was directed to the minutes of the meeting of Jan. 9. Inasmuch as the official minutes of the meeting of Jan. 9 were published in the March/April 2013 issue of the CDS Review, a motion was entertained to dispense with reading them.

MOVED by Richard Holba, seconded by Susan Becker Doroshow and carried to dispense with reading the Jan. 9 minutes.

MOVED by Ilie Pavel, seconded by Phillip Fijal and carried to accept the minutes of the meeting of Jan. 9.

There were no reports of the Board or Standing Committees.

There were no reports of Special Committees.

There was no Unfinished Business to report.

NEW BUSINESS: Proposed Change to the CDS Constitution and Bylaws Dr. Fulton reported that the Chicago Dental Society, as part of tripartite dentistry, uses the Sturgis Code of Parliamentary Procedure to govern the deliberations of the Society. At the 2011 American Dental Association House of Delegates, a change from Sturgis to the American Institute of Parliamentarians (AIP) Standard Code of Parliamentary Procedures (formally Sturgis Standard Code) was adopted. The Illinois State Dental Society will also make this governance change effective in 2013. The AIP publication provides important new motions and protocols pertaining to electronic meetings, discipline, and finance and audit committees. It is therefore proposed that CDS change its Constitution and Bylaws to reflect its governance under this new parliamentary procedures publication and to remain in compliance with the ADA and the ISDS.

Dr. Fulton reported that the proposed change to the CDS Constitution and Bylaws was published in the January/February and the March/April issues of the CDS Review in accordance with Article 24 of the CDS Bylaws, requiring a two-thirds affirmative vote of the active members present.

Dr. Fulton inquired if anyone wished to discuss the proposal. Seeing none, Dr. Fulton called for the vote on the proposed change to the Constitution and Bylaws. CDS members each received a colored voting card at Registration when picking up their badges. Members were asked to raise the voting card to indicate whether a vote of "yes" to approve the change or "no" to reject the change.

The following change to Page 19, ARTICLE XXII, Rules of Order, passed unanimously: The current edition of the American Institute of Parliamentarians Standard Code of Parliamentary Procedures shall govern the deliberations of this Society in all cases to which they are applicable and consistent with these bylaws.

With no further business, Dr. Fulton called upon Regional Meeting Program Chair Maria Fe Corpuz-Bato to introduce Suzanne Bozwell, the speaker. She presented the program "The Cohesive Team: Developing a Confident Team to Manage Daily Challenges."

The meeting was adjourned at approximately 1:30 p.m.

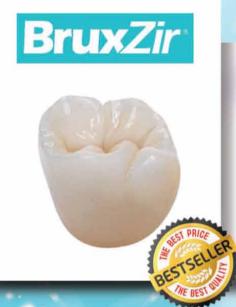

he number of people older than 65 years is rising, and those more than 85 years old are the fastest growing subset in the population. But dentists often lack special expertise in treating them, according to Janet Yellowitz, director of geriatric dentistry at the University of Maryland.

Although many seniors don't have any special needs, quite a few are medically complex or cognitively impaired, she said. They may have conditions or medications that affect oral health, or have physical or cognitive disabilities that make them more challenging to treat.

"This requires patience," Dr. Yellowitz said. For example, it takes longer to interview people with cognitive impairments, and regular tooth brushing can be hard for them to remember.

This group of patients often has significant dental problems. A 2000 study by researchers at the University of Iowa, reported in the Journal of the American Dental Association, found that in a cohort of people 79 years old and older, nearly all of them had experience with coronal decay, and one in four had untreated root caries.

Further highlighting their need for care, a separate, longitudinal study by the U.S. Centers for Disease Control and Prevention (the Third National Health and Nutrition Examination Survey) showed that 24 percent of people in the United States ages 65-74 have lost all



their teeth. Among those over 75, nearly a third had lost all their teeth, researchers reported in the June 2012 issue of the Journal of the American Dental Association.

Dr. Yellowitz offered some tips for treating older patients:

Urge regular checkups. Many elderly people grew up in a time when regular dental checkups were rare: you







only went to the dentist when you were in pain. But as people age, their teeth have fewer nerves and they are less sensitive to pain: they may not even notice serious dental problems. Seniors should visit the dentist at least once a year, getting a complete oral assessment, an oral cancer screening and, if applicable, a denture check.

Identify impairments. Physical disabilities like arthritis make it harder to brush and floss. Dementias, including Alzheimer's disease, impede regular oral hygiene and make it harder to communicate with the patient. Diabetes slows the healing process, so it may take longer to treat gum disease. A senior may take many medications, and some of them can cause dry mouth.

Ask about dry mouth. Some geriatric conditions and hundreds of medications can cause dry mouth. Identify the source of older patients' dry mouth and help them deal with it. Recommendations might include sipping water, sucking on sugarless candies, and using an alcohol-free mouthwash.

Include caregivers in the visit. Family members and other caregivers may not know how to help elderly people with their regular dental care. Show them how to brush someone else's teeth and care for dentures.

Suggest changing toothbrushes. Some elderly patients can't use a regular toothbrush as well as a knife and fork. An electric toothbrush has a thicker handle that is easier to pick up. Also, they should be brushing their gums as well as their teeth. Suggest these changes tactfully, such as by saying "Let's try something a little bit different."

Be respectful. Communicate clearly, using a tone of respect and reassurance. Speak slowly and directly, and be considerate of patients who have hearing problems.

Decide which patients you'll need to refer. If you're not comfortable treating impaired elderly patients, refer them to dentists who see geriatric patients.

Steps to prepare your practice for geriatric patients

With the projected rise in the number of U.S. seniors, it's a good time to make sure your practice can serve the needs of this population. Dr. Yellowitz suggested a few ways to prepare your practice for geriatric patients.

Take courses in dental geriatrics. The American Dental Association and many local professional organizations, including CDS, offer continuing education courses on geriatric dentistry for all members of the dental team.

Understand medical-dental links. Be aware of the relationship of dental health to the rest of the body, and the effect of medications on dental health. When there seems to be a problem with your patient's health status, contact his or her primary care physician.

Include geriatrics-related questions on your health history form. On the form your patients fill out before the visit, ask about medications and dry mouth, for example. Sample questions: "Do you need to drink fluids in order to swallow?" or "Is your mouth dry most of the time?"

Plan more time for appointments. Longer appointments may be needed to accommodate the slower pace and special needs of geriatric patients. Use the extra time to gain knowledge of the patient's dental history, medications, physical health and care-giving arrangements.

Provide regular oral cancer screenings. An oral cancer screening is important for all patients, but it is especially important for the elderly, who have higher risks of oral cancer. The screening includes a visual inspection of the mouth and palpation of the jaw and neck. While most dentists provide oral screenings on the initial visit, many do not provide regular exams after that, Dr. Yellowitz said.

When there seems to be a problem with your patient's health status. contact his or her primary care Physician.

Address proper denture care. Make sure dentures fit well. Some older patients may be wearing dentures that were put in decades ago. Remember that dentures may cause pain or fall out easily due to weight changes. Discuss with patients and care-givers proper denture care, including use of a non-abrasive toothpaste and overnight soaking.

Consider providing care in nursing homes. There is a great need for dental care in nursing homes. Providing on-site care there can be a great practicebuilder.

Edwin Troutt, DDS. 114th CDS PRESIDENT

r. Edwin Troutt, who served the Chicago Dental Society as its 114th president, died June 27 in Pompano Beach FL. He was 84 years old.

A native of Ponca City, OK, Dr. Troutt graduated from the University of Oklahoma and the Northwestern University Dental School, graduating in 1954. He served as Program Chair of the 1969 Midwinter Meeting, and the following year he was on the Reception Committee. He served many years on CDS's Public Relations Committee. He was also a delegate to the American Dental Association.

Leading up to his term as CDS president in 1977-78, Dr. Troutt was a member of the North Suburban Branch; he served as treasurer, secretary, vice president and president-elect. But when the Northwest Suburban Branch was organized, Dr. Troutt moved over and served

as its first president in 1972-73. Dr. Troutt's legacy continues, as his son-inlaw, Jeffrey Eaton, and granddaughter, Rebecca Montgomery, are members of CDS's Northwest Suburban Branch today.

Celebrating his inauguration May 19, 1977, Dr. Troutt told the crowd gathered at the Conrad Hilton Hotel that he was proud to be part of such a large component society.

"But numbers alone don't make for a good society," he continued. "Chicago Dental Society is good because of the people in it. Also, Chicago Dental Society is good because of the legacy of the people who have served it in years past...

Among the benefits that I treasure most are the friendships I have made during my 20-year membership in the Chicago Dental Society. It hasn't been all work and no play."

A year later, he reflected on his term in the pages of the CDS Review, and offered advice to those dentists who would hold office in the years and decades to come.

"It is my hope that this willingness to change and to innovate will continue to be a dominant factor in Chicago Dental Society growth. We need to be flexible to maintain and improve the position of the dental profession within the rapidly shifting framework of our modern but still developing world."

Walter Lamacki, editor of the CDS Review, who was a freshman member of the Board of Directors during Dr. Troutt's presidency, recalled, "He was a very organized and focused individual. He had goals for his presidency and made his goals."

Dr. Troutt is survived by his wife of 61 years, Muriel. ■

"What was wonderful was that there was not a person who came through who wasn't blown away by how lovely and professional the atmosphere in the office is," said Keith Suchy, president of the clinic's Board of Managers.

"Our expectations were more than met," added CDS Foundation Board chair Milly Goldstein. "Not only did we have more than the expected visitors, they visited and stayed, asking questions about how we put it together, what do we need, and how can they volunteer."

Active clinic volunteers had much to tout at the Open House. They've delivered more than \$110,000 worth of dental treatment to 242 patients of record in their first four months of business.

If you offer Botox, don't skimp on training

en percent of the dental profession is providing Botox treatment. A segment of dentists believe that Botox treatment, when used properly, enhances facial esthetics in conjunction with cosmetic dentistry. Whether you provide Botox therapy or you are thinking about adding it to your practice, be aware that there are considerations at both the state dental board and risk management levels.

No of the state of Botox is a brand name for Botulinum toxin, which causes muscle paralysis. By paralyzing certain facial muscles, Botox can prevent wrinkles and the visual effects of aging. However, the effects are temporary (generally 4-6 months), so further injections are needed in order to continue the effect. In addition to its cosmetic effects, Botox has been used for certain types of TMJ disorders that are more muscular in nature. By causing certain masticatory muscles to relax, Botox can help relieve the clenching and stress put on the mandible by these muscles.

Most states allow general dentists to perform Botox in the oral and maxillofacial areas with proper training. According to the Illinois Department of Financial and Professional Regula-

tion, "The use of Botox and other injectable cosmetic treatments falls within the scope of dentistry as long as it involves conditions within 'the human oral cavity and its adjacent tissues and structures." However, properly trained and experienced dentists must administer these treatments. The key phrase is "properly trained."

The second element that the dental professional must consider before adding Botox to his or her practice is whether their malpractice carrier will cover the procedure. There are already documented cases in Illinois and the surrounding states of patients sustaining significant injuries from an improper administration of Botox, including necrosis of

If you decide to offer Botox to your patients, check with the dental board in your state to see if it permits such treatment.

the lip, nerve injury, infections, and permanent alteration of the

Properly trained and experienced dentists must administer these treatments. The key phrase is "properly trained."

©patpitchaya / Shutterstock Images And if your state dental board does permit the use of Botox, then make sure to obtain the proper training (not a weekend

course). Also, be sure that your Botox treatment has some connection to your dental treatment plan. In addition to state dental board permission and adequate training, the dentist must also make sure that his or her dental malpractice carrier covers the use of Botox.

Kelly Skerrett finds her outlet through abstract art

s a child, Kelly Skerrett loved creating art. But as a young adult, she saw her creativeness evolve when she began to paint.

"I use a lot of colors and textures, and I usually just paint and see what happens with whatever comes to mind," said Dr. Skerrett, a 2008 graduate of the University of Buffalo School of Dental Medicine who practices in Chicago.

"I like to allow the people who view the paintings to see whatever they want. I want the person to use the painting as a way for them to see something I don't see or to lose themselves in it and connect with it.'

Dr. Skerrett originally wanted to be an art major, but she also had an interest in medicine. She decided on dental school, and now finds painting is a great release after a long day of practicing dentistry.

While some artists paint landscapes, portraits or still lifes, Dr. Skerrett likes to paint abstracts. Some of her greatest influences are local artists and the late Jean-Michel Basquiat, the Neo-expres-



sionist painter from New York.

This spring, Dr. Skerrett jumped on an opportunity to showcase her work for the first time at a friend's bar, Parlour on Clark. The venue allows local artists to display their work in its gallery space. To celebrate, Parlour hosted a gallery opening for Dr. Skerrett with a champagne reception.

"I was really excited, but shy about it. I'm usually very private about my work, but I thought it was a step forward for me to show people what I can do," she said.

Dr. Skerrett hopes to present another show in the future. In the meantime, she is working on new paintings while she continues to practice dentistry.

"I think that painting has actually helped me become a better dentist because of the dexterity and creativity," said Dr. Skerrett. "For me, personally, it has helped me look at things more artistically in someone's mouth rather than always scientifically.

"I'm going to keep going with (painting) and see where it takes me. Even if it doesn't go anywhere, I just have fun with it." ■

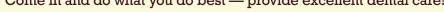

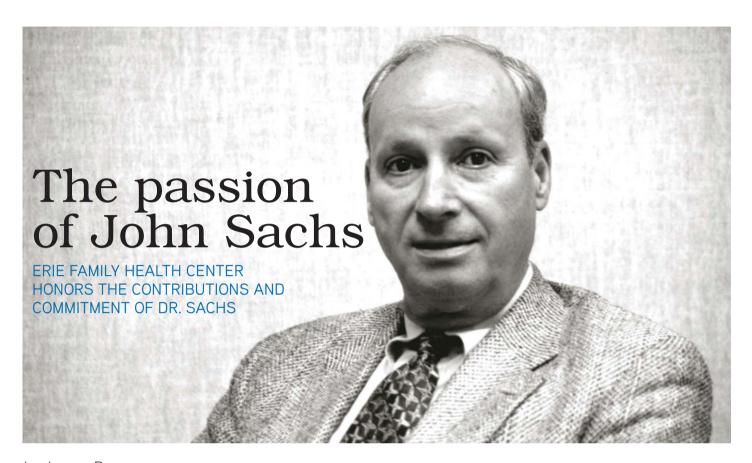






ACCESS TO CARE

A look at challenges facing our profession.

s an oral surgeon in the northwest suburbs, John Sachs for decades worked to restore his patients' oral health. But his free time was dedicated to early intervention that would keep the Erie Family Health Center's dental patients out of the oral surgeon's office.

Dr. Sachs was honored in May with the Erie Family Health Center's Golden Toothbrush Award for his commitment to oral healthcare as a provider and an advocate for access to care. Erie Family Health Center provides affordable, accessible care to patients in need.

"He helped Erie as an early advisor to our dental program, and demonstrated his life-long commitment to respectful, high-quality care," said president and CEO Lee Francis, reflecting on his calls to Dr. Sachs when Erie was developing an oral health program in 2005.

Erie Family Health Center has 13 locations throughout Chicago and the suburbs, including two dental clinics. Four more health centers will be added in Evanston, Waukegan, Mundelein and Chicago.

Erie Family Health Center provided basic, dental and behavioral health services through 150,000 visits in 2012, including 40,000 patients.

"He had all sorts of ideas. As an oral surgeon I think he had seen the end stages of disease and patients go through a lot of treatment that could have been prevented through early intervention. The world and status of oral health would be a lot more advanced if we had more people like Dr. Sachs lending their experience and sage advice."

Dr. Sachs escaped Germany for the safety of Holland in 1935, and arrived in the U.S. in 1941. He entered medicine after serving in the U.S. Army. According to Melissa Hilton, vice president for development and communica-





tions at Erie Family Health Center. Dr. Sachs's commitment to the organization is two-fold: there's his enthusiasm for supporting the growth and development of professionals in medicine, and also his deep commitment to patient access to quality care that is delivered with dignity and respect.

That's exactly the kind of care that Erie aims to provide through its network of 13 centers (including two dental clinics), which serve 40,000 patients in Chicago and the suburbs. Since 1857 Erie Family Health Center has focused on preventive care that reduces healthcare costs, improves health outcomes and reduces health disparities. Clinics offer vaccines, chronic disease management, health education, school checkups, prenatal care and dentistry, among other services.

With a staff of 425, Erie Family Health Center provided primary, dental and behavioral healthcare through 150.000 visits in 2012. Erie Family Health Center will add four more centers to the mix by the end of 2014, in Evanston, Waukegan, Mundelein and Chicago, on the campus of Swedish Covenant Hospital.

Also honored by Erie Family Health Center in May were Evanston Mayor Elizabeth Tisdahl and Skokie Mayor George van Dusen, with the Health Innovator Award. Dr. Francis lauded their work to bring affordable health services to their communities via a new Erie Family Heath Center facility. This site will include a dental center, in addition to primary care and behavioral health services.

"Some of our primary advisors are our own patients, and more than 50 percent of our Board of Directors is patients and users of our health services," Dr. Francis described. "Talk about great advice: we don't have to guess what happens on our front lines."

Surgeon General endorses community water fluoridation

U.S. Surgeon General Regina Benjamin April 22 officially endorsed community water fluoridation as "one of the most effective choices communities can make to prevent health problems while actually improving the oral health of their citizens."

Dr. Benjamin made her endorsement in a letter sent to the National Oral Health Conference held in Huntsville, AL. Attendees heard the letter read aloud at the Opening Ceremony.

"Fluoridation's effectiveness in preventing tooth decay is not limited to children, but extends throughout life, resulting in fewer and less severe cavities," Dr. Benjamin wrote. "In fact, each generation born since the implementation of water fluoridation has enjoyed better dental health than the generation that preceded it."

Every surgeon general for the past 50 years has endorsed fluoridation of community water supplies as a safe and effective weapon in the war against tooth decay.

The American Dental Association has supported fluoridation since 1950.

"The ADA's policies regarding community water fluoridation are based on the best available science showing that fluoridation is a safe, effective way to prevent dental decay," said ADA President Robert Faiella. "The ADA, along with state and local dental societies, continues to work with federal, state and local agencies to increase the number of communities benefiting from this very effective public health measure."

ADA report: National dental spending flat since 2008

New analysis released by the American Dental Association indicates that overall spending on dental care has remained flat in recent years, despite the fact that per patient dental spending by Baby Boomers and seniors increased.

Two research briefs released by the ADA's Health Policy Resources Center (HPRC) bolster previous statistics showing that adult dental visits have been declining from 2000-2010, leading to less spending on dentistry and oral care. Significantly, the declines in both dental spending and visits predate the economic crisis of 2008.

"Our results suggest very strongly that the dental economy is in a major transition," wrote Marko Vujicic, managing vice president of the HPRC and lead author of the briefs. "Dental spending has not rebounded since the end of the Great Recession and has been stagnant, on a per capita basis, since 2008.'

In 2011, dental spending accounted for 4 percent of overall national health expenditures, down from 4.5 percent in 2000, according to HPRC analysis of data gathered from the Center for Medicare and Medicaid Services, the Bureau of Economic Analysis and the U.S. Census Bureau.

The rate of growth of dental spending has also slowed in recent years. Between 1990 and 2002, per capita dental spending grew by 3.9 percent per year after adjusting for inflation, a rate that fell to 1.8 percent between 2002 and 2008. Since 2008, the per capita dental expenditure growth rate declined 0.3 percent while overall health spending grew by 1.6 percent.

According to a previous HPRC brief, in 2003 41 percent of adults reported going to the dentist during the prior year. That figure declined to 37 percent in 2010. Children, however, visited dentists more often between 2003 and 2010, but since their dental care tends to be less expensive than adults', it did not result in greater dental spending overall.

While overall dental expenditures have remained flat, the HPRC analysis shows there's more to the story — spending by Baby Boomers and the elderly is on the rise. Between 2000 and 2010, seniors' annual spending on their dental care increased from \$655 to \$796. The HPRC credits the increase to advances in preventive and restorative dental care, leading to greater numbers of elderly retaining their teeth.

"Thanks to greater understanding of the importance of oral health and mouth healthy measures such as water fluoridation, the dental well-being of Americans has improved in recent decades," said ADA President Robert Faiella. "According to the Centers for Disease Control, the number of adults missing all or some of their teeth dropped from 50.2 percent in 1999 to 43.6 percent in 2010. But as positive as this trend is, the fact that fewer adults are utilizing dental care jeopardizes that progress. Financial barriers to care are up among young adults, and the number of people who visit the ER for their dental care is rising. We need to find creative solutions to improve access to care for millions of Americans and reverse these recent trends."

Bringing up baby

inky. Paci. Mimi. Boppy. Whatever you may call your child's pacifier, the American Dental Association has released new data about it. A study recently published in Pediatrics, the journal of the American Academy of Pediatrics, said that licking your child's pacifier to clean it is acceptable. However, the ADA feels that adult saliva may contain a variety of microorganisms which may be harmful to an infant's health and may increase the baby's chance of developing tooth decay.

The ADA suggests just rinsing a paci-

fier that has dropped on the ground with soap and water or running it through the dishwasher. It also advises against sugar coating a pacifier with sweeteners such as sugar, honey, juice or sweetened drinks, as this can increase the risk of cavities.

Remember to also not put the baby's feeding spoon in your mouth, as this can also pass bacteria to the baby.

The ADA also suggests some other ways to help develop a child.

• Breast milk is a good immunity builder as well as a complete form of nutrition for infants.

- · Promote a healthy diet and monitor their food and drink.
- Brush your child's teeth or wipe their gums after mealtimes.
- · Give infants their naptime or bedtime bottle before going to bed.
- Children should see a dentist for the first time no later than 12 months of age.

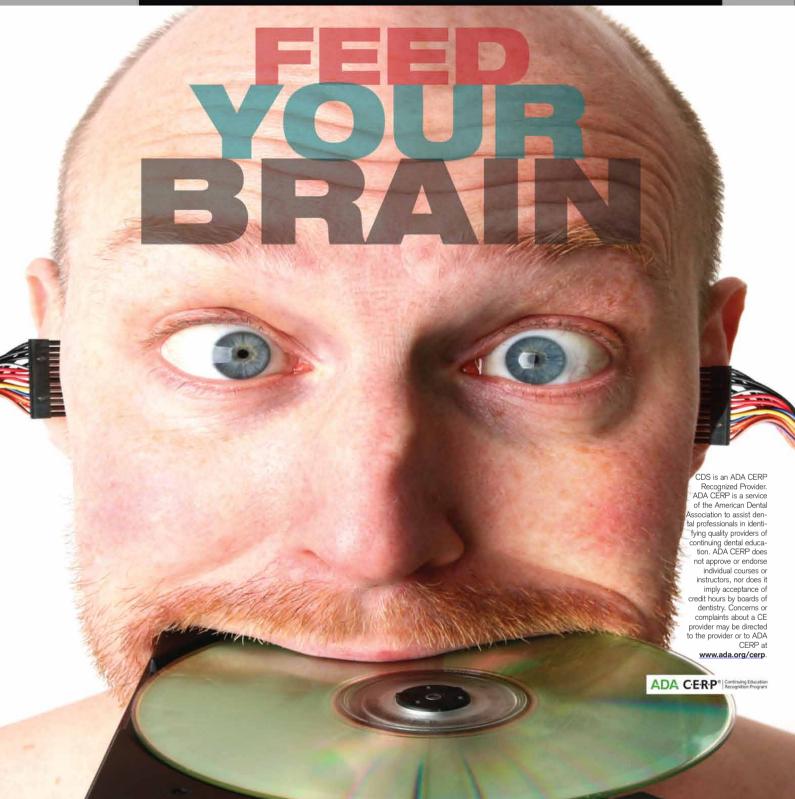

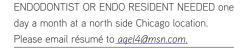

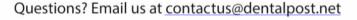

Is ownership 9/10 of the law?

orty years ago, the Illinois State Dental Society had a committee called Protection of Public Health. The committee's task was to identify and take legal action against unlicensed persons practicing dentistry. While the committee no longer exists, its work has been taken over by a professional investigator employed by the state.

At the time the committee was established, non-dentist owners hired dentists to front their operations and legitimize their

unlicensed businesses. Thanks to the legal actions taken by the committee, the courts handed down severe fines against the operators and the Dental Examining Board suspended the straw man's dental license. These actions upheld the Dental Practice Act's ownership provision, which states that only a licensed dentist can own a dental practice in Illinois. Nearly all states' dental practice acts have similar language.

Today that ownership regulation is allegedly being broken by some dental management companies (more commonly known as corporate dentistry) that have sprung up like dandelions in the last

decade. Their websites tout their support services that purportedly streamline a dental practice. However, some management companies have been accused by North Carolina and other states of violating their ownership clauses. Accusations of overtreatment and insurance and Medicaid fraud fill the blogosphere.

A crescendo of allegations has reached the floor of the Senate. Sen. Charles Grassley (R-IA) demanded an accounting of ownership, parental notification and participation in Medicaid from Kool Smiles, Small Smiles and ReachOut Healthcare America; all three treat Medicaid children almost exclusively. Sen. Grassley said, "You have dentists under pressure to perform more services than may be necessary. . ."

Parents of children treated by these companies have reportedly complained that treatment involves cruel and abusive physical restraint by the overuse of papoose boards. However, none of the companies has been charged with violations of any laws because of their treatment methods.

Although Aspen Dental Management Inc. doesn't accept Medicaid cases, it, too, has come under scrutiny by the senator for alleged promotion of unnecessary treatment plans which

have, he said, ". . . exorbitantly expensive credit arrangements." Aspen is associated with 300 clinics in 22 states.

In September, a North Carolina State Board of Dental Examiners won a consent order against Heartland Dental Care, a dental management company, and an individual dentist for violation of the state's Dental Practice Act ownership provisions. The dentist received a two-year suspension, but it may be stayed if he follows a list of conditions, including not having

any contact with Heartland. Heartland was assessed \$36,818 by the examining board, the cost of the investigation

Heartland's majority owner at the time was Rick Workman, DDS, of Effingham. According to the company's website, it provides administrative support to 500 dentists in 21 states. On Nov. 5, Dr. Workman sold a majority interest in Heartland to the Ontario Teacher's Pension Plan for \$1.3 billion; he retains a significant position in the stock. The plan has assets of \$117 billion and Heartland is one of only three investments that have more than \$1 billion in its portfolio.

There is no doubt "dental management" by third parties is big business. Will the teachers' pension plan — with its major investment in Heartland and its deep pockets — appeal the North Carolina court's decision to protect its investment? I think so.

That's their business.

Our business is to make sure that a dentist owns his practice and treats patients fairly and ethically, and that only the dentist and patient make treatment decisions. Our code of ethics demands no less. That defines the profession.







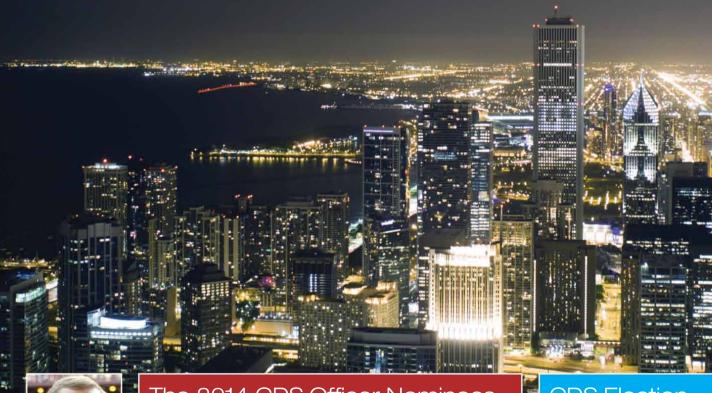

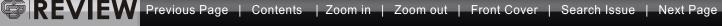
