November 13 Regional Meeting minutes

The Regional Meeting of the Chicago Dental Society convened Nov. 13 at the Drury Lane Oak Brook, Oakbrook Terrace, with CDS President David Fulton Jr. presiding.

Dr. Fulton called the meeting to order at 9:05 a.m.

Attention was directed to the minutes of the meeting of April 24. Inasmuch as the official minutes of April 24 were published in the July/August 2013 issue of the *CDS Review*, a motion was entertained to dispense with reading them.

MOVED by George Zehak, seconded by Maria Fe Corpuz-Bato, and carried to dispense with reading the April 24, 2013 minutes at this time.

MOVED by Susan Becker Doroshow, seconded by Louis Imburgia, and carried to accept the minutes of the April 24, 2013, meeting.

There were no reports of the Board, standing or special committees.

There was no unfinished business to report.

Dr. Fulton reported that nominating petitions for the 2014 officers was duly filed in the CDS central office, and their names published in the May/June, July/August and September/October issues of the *CDS Review*, in accordance with the bylaws.

Dr. Fulton further reported that since not more than one candidate had been nominated for each elective office, in accordance with CDS Bylaws, the secretary would cast a single unanimous ballot on behalf of all the respective candidates for office.

MOVED by Loren Feldner, seconded by James Bryniarski, and carried that a single unanimous ballot be cast on behalf of all the respective candidates for office.

Dr. Fulton then congratulated Treasurer-elect Louis Imburgia, Vice President-elect Phillip Fijal, Secretary-elect George Zehak, and Susan Becker Doroshow, who will become president-elect.

He noted that these officers would be installed Nov. 17, along with Richard Holba, who will assume the office of president. These officers will assume their respective duties January 1 and will continue through Dec. 31, in accordance with the fiscal year.

Dr. Fulton extended an open invitation to all CDS members, their families and friends to join them on this occasion at the Palmer House, to personally congratulate them and wish them well while enjoying refreshments. Dr. Fulton noted that CDS's 50-year graduates would also be recognized at that time.

With no further business, Dr. Fulton called upon Regional Meeting Program Chair Maria Fe Corpuz-Bato to introduce William Blatchford, DDS, to present his program entitled, "Ten Steps to Grow Your Practice."

The meeting was adjourned at approximately 1:45 p.m. ■

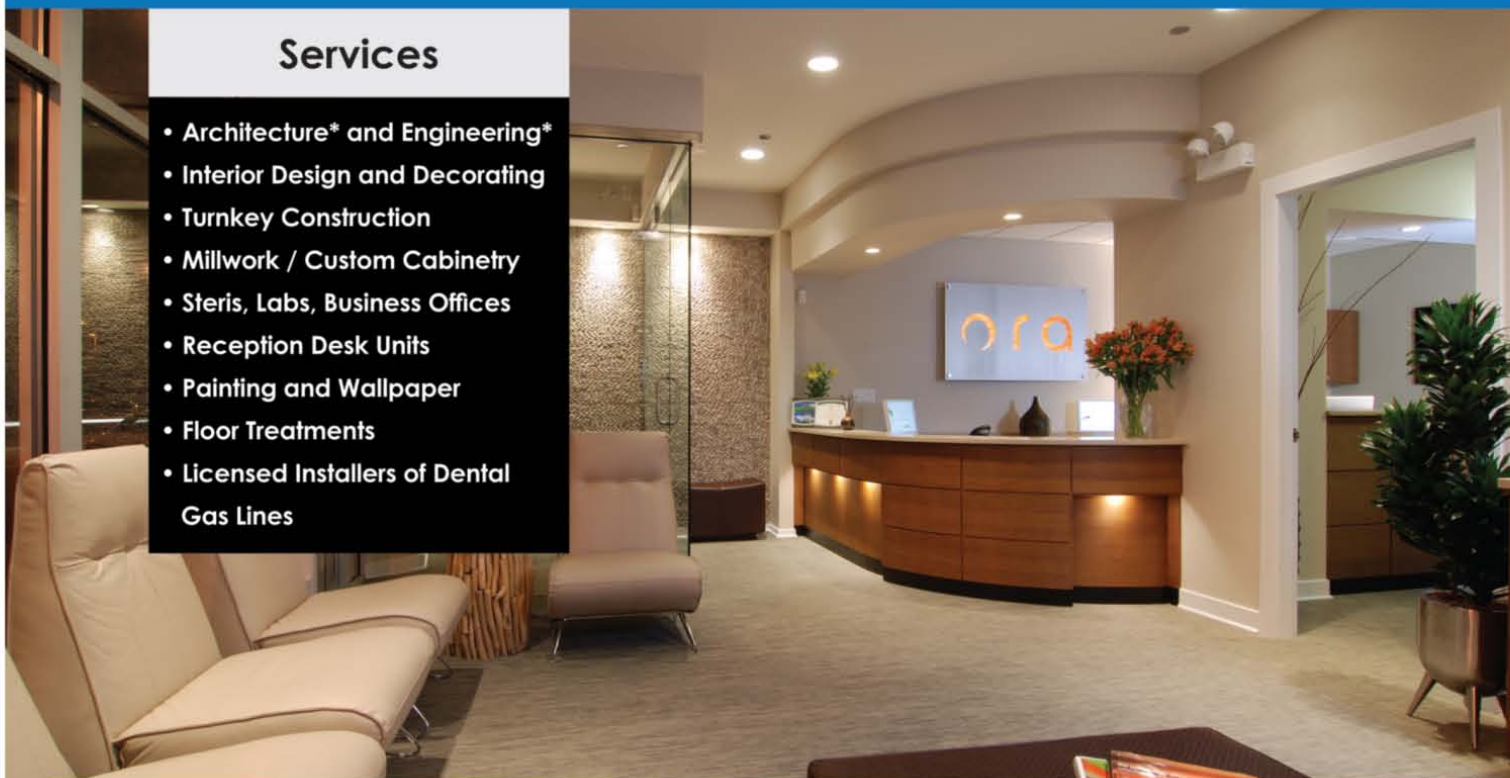

Q & A

WITH

Richard Holba

2014 CDS PRESIDENT



CDS Review editor Walter Lamacki spoke with CDS President Richard Holba. They discussed the history and future of dentistry, as well as plans for the 149th Midwinter Meeting.

YOUR MIDWINTER MEETING THEME IS “THE BRIDGE: PAST, PRESENT, FUTURE.” WOULD YOU EXPAND ON THAT THEME, ESPECIALLY THE FUTURE?

I selected *The Bridge* as a theme because of its symbolism and of course usefulness. It is a term that is useful not only in dentistry but in music, plays, billiards and science; it is the link from point A to point B and beyond.

Because I am fortunate to serve as president as we begin our celebration of 150 years of the Chicago Dental Society (though not the 150th Midwinter Meeting), I thought the theme would be a great way to link the past, the present and the future of our efforts to excel in meeting the needs of the dental community.

It is the Midwinter Meeting that enables us to continue our education, improve our techniques, and improve patient health. I believe our meeting has consistently achieved these goals, and will continue to do so in the years to come.

I think planning for the future is exciting and important. We have to look ahead so that our society will not become stale, non-essential or without value.

The new horizons are expanding with the aid of digital enhancements in diagnoses, treatment planning, and the construction of final prosthetic devices. The possibilities of future vaccines and stem cell treatment make it hard to comprehend.

It is amazing how our previous discussions have changed from waxes, denture teeth, different types of alloy, and gold to CAD/CAM construction, digital images, design and implants. The future is exciting with its new ideas and new challenges to the art and science of dentistry.

WHAT ADVICE WOULD YOU GIVE TO A SENIOR DENTAL STUDENT?

I frequently recall the advice spoken by a past superintendent of the Chicago Public Schools, Benjamin Willis: “You will need to be a student for the rest of your life.”

I would add that for most of your life, nothing will come easy; you have to work at it. I believe that through the various programs offered by organized dentistry you can achieve your goals.

WHAT CAN YOU AND THE BOARD DO TO INCREASE MEMBERSHIP?

That question is the hardest one to answer for organized dentistry. This problem has been difficult for past and present boards and most likely will plague future ones.

I believe we have to be open-minded and try whatever needs to be done. We need to listen to the new dentists and their concerns, but also to all dentists so that we can attract and retain them well into their careers. It is very possible that some of the methods or ideas may be outside our comfort zones — to use today's vernacular "outside the box." I believe our board will work hard at attracting and maintaining membership with the aid of our various CDS committees and volunteers.

WHAT'S NEW AT THE MIDWINTER MEETING THIS YEAR?

Some of the new things this year are the location of the live televised demonstration theater and our Rebate Redemption Center. Also, rebates may only be redeemed in the Exhibit Hall this year, not by mail as in years past. We hope this change will make your coupon redemption experience easier, and it ensures that you will be rewarded for supporting our exhibitors.

Also we will award CE credit for visiting the exhibit floor. Receive one hour of CE credit per day when you visit the Exhibit Hall.

And at this year's Midwinter Meeting, we're happy to continue the New Dentist Reception. It's a great event and a great value for our newest colleagues.

I FREQUENTLY RECALL THE ADVICE SPOKEN BY A PAST SUPERINTENDENT OF THE CHICAGO PUBLIC SCHOOLS BENJAMIN WILLIS: "YOU WILL NEED TO BE A STUDENT FOR THE REST OF YOUR LIFE."**WHAT IMPACT IS SO-CALLED CORPORATE DENTISTRY HAVING ON ORGANIZED DENTISTRY?**

The impact of corporate dentistry is still an unknown. I think that the complete answer to this question will come over time.

Due to the amount of debt that most new dentists have upon graduation, joining a corporate clinic is an attractive way to begin their careers.

The question is whether this will be their permanent place or just a temporary stop in their career path. If they stay, will the corporate headquarters be their sole source for continuing education and development? Will that environment hamper their ability to be involved? Are there barriers in place to prevent them from seeing the value of our tripartite system?

I see far more questions than answers at this time.

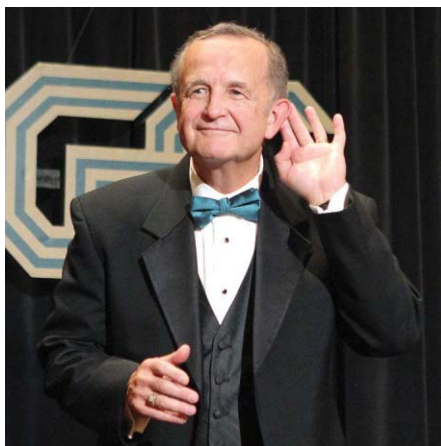

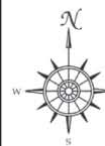

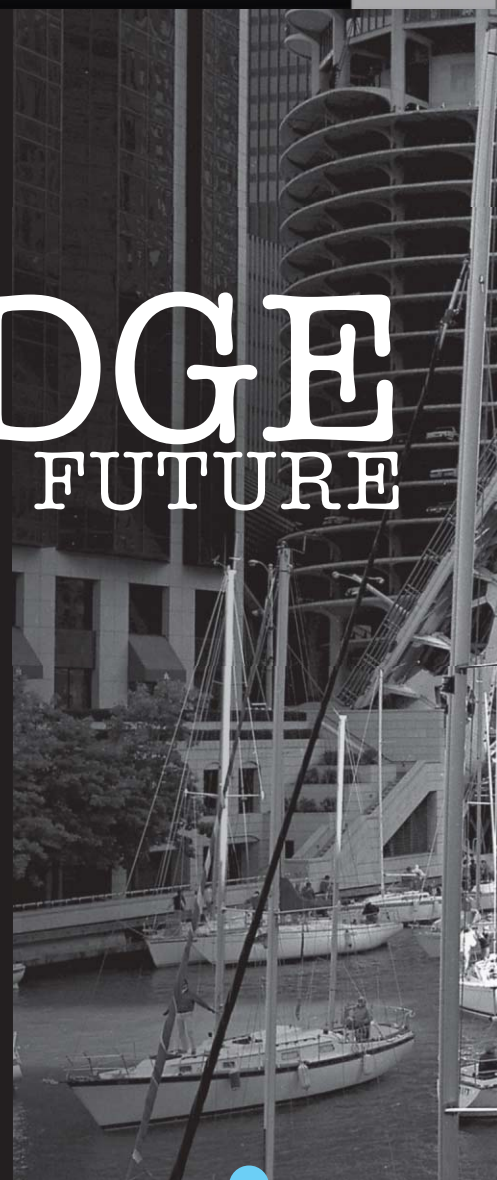

It's been 149 years that the Chicago Dental Society has hosted the Midwinter Meeting, our annual celebration of dental science and technology, and CDS President Richard Holba hopes that this year's participants feel connected to all those who have contributed to the meeting's longevity. They are, after all, why he selected the meeting theme, *The Bridge: Past, Present and Future*; it emphasizes the role of organized dentistry in the evolution of his beloved profession.

"I selected the theme because a bridge is a connection. For the sake of our meeting, it is a connection for learning, meeting old and making new friends, and being a part of a great organization," Dr. Holba said.

The 149th Midwinter Meeting opens at McCormick Place West Thursday, Feb. 20. Registration continues through Feb. 14 at www.cds.org to reserve your spot at this three-day confluence of continuing education and commercial exposition.

"I believe it is important to attend the Midwinter Meeting every year because our profession is not static," Dr. Holba said. "New materials, instruments and techniques are being developed all the time. 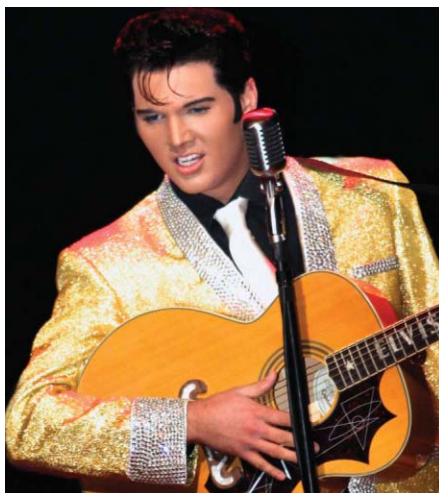

DENTISTRY AND THE AFFORDABLE CARE ACT

It has been several years since I have written this column; I am excited to be back at the desk after my sojourn with the Chicago Dental Society Board of Directors.

In that time, there have been lots of new developments that will affect dentistry, none more so than the gradual implementation of the *Patient Protection and Affordable Care Act (ACA)*.

IMPACT

On the surface, the impact of the ACA on dentistry appears to be minor, as dentistry was not at the center of the negotiations of this law. But make no mistake: the implementation of the ACA will eventually have a far-reaching effect on dentistry. While the ACA does not contain provisions regulating the insurance coverage of adult dentistry, it does affect the coverage of an increasing number of children. Illinois mandates that insurance plans offer dental benefits for children under the Act, but it does not mandate that parents actually purchase a plan for their children.

Beginning this month, the impact of the ACA will be felt by dentists providing pedodontic and orthodontic care. However, it is still too early to foretell the ramifications of this new insurance regulatory framework, as the implementations of many rules and regulations are still a work in progress. But I intend to cover the effects of the ACA on dentistry in future columns as more information becomes available. In the meantime, we will have to roll with the punches, so to speak.

REIMBURSEMENT

The new healthcare law envisions reimbursement procedures that move away from traditional fee-for-service arrangements and toward a concept of evidence-based re-imbursement. The Ameri-

can Dental Association has provided excellent programs explaining and promoting evidence-based dentistry by providing seminars for its member dentists.

Many questions remain.

While evidence-based dentistry emphasizes outcomes of treatment rather than the performance of individual procedures, how will we measure the value of the services rendered?

What (scientific) information will be available to decide what procedures work under which circumstances and which procedures are to be avoided?

We know as careful practitioners not to place expensive dental work into the mouth of a patient who is not committed to adhering to basic hygiene protocols.

However, will the day come when an insurance carrier might be able to refuse payment for orthodontic work on a teenager whose oral hygiene does not live up to a certain care standard?

What will happen to a dentist's assertion, "but in my hands this procedure works"? Presumably, this approach to dentistry will not be sustainable in the long run and will gradually be replaced by evidence-based guidelines as is increasingly the case in medicine.

It seems clear that, in order to support a new evidence-based approach to dentistry, we need more research to support the effectiveness of certain procedures, if only to counter claims that certain treatments are not evidence-based.

The new regulatory environment creates new challenges for the doctor-patient relationship. What are specific ethical and legal considerations under the ACA and evidence based dentistry? In the next column, the impact these new regulations might have on the everyday practice of dentistry will be discussed. ■

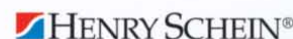

As student debt grows, new dentists choosing financial stability over starting practices

In many respects, today's generation of new dentists is inspired by many of the professional qualities that motivated veteran dentists in their day, primarily a strong entrepreneurial drive, control over their time, service to others, and working with their hands.

Where do they part ways with their older colleagues? Numbers. Money. And, specifically, debt.

"Admission into dental school is more competitive than it has been in the past," said Reena Patel, a 2001 graduate of Northwestern University Dental School. "Incoming students really have to be at the top to get in."

"One of the biggest burdens that dental students are facing today is the rising cost of tuition. It has increased at an exponential rate, and students are graduating with incredible financial debt. This in turn influences the career path they choose. We have seen a shift in students joining corporate dentistry instead of independent, private practices."

Looking at the numbers, there are more accredited dental schools open today (65) than ever before. Applications peaked at nearly 23,000 in the early 1980s, but plateaued at about 20,000 in 2010-11. The cost of pursuing a dental education, even adjusted for inflation and in "real dollars," has never been higher; averages span from \$180,000 (public schools) to \$220,000 (private).

While income for new dentists able to start or buy a private practice can exceed \$100,000, according to the ADA's 2008 survey on new dentists, 91 percent of new dentists say they couldn't afford to start their own practice. Salaries for employee new dentists range from \$40,000 to \$90,000.

"We have noticed in the past years that our residents are not too eager to start their own or buy into solo practices," confirmed Dr. Patel. "I think financial stability is really the most important factor. Due to their debt/loans, they prefer to join practices that will pay them a 'guaranteed' salary."

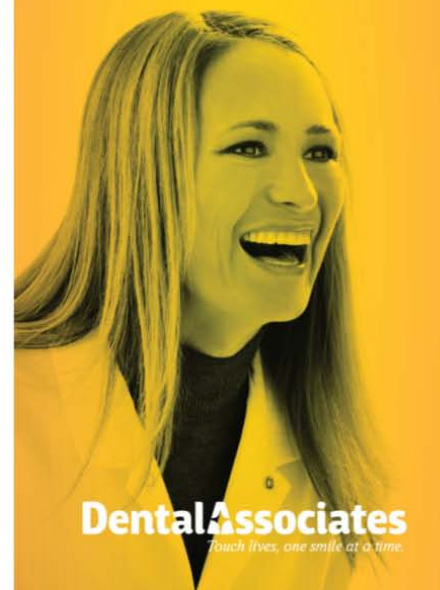

THE DRAKE MEETING

January 17th, 18th and 19th

Total attendance: 4,911

Thirty-one states and the District of Columbia were represented, as well as seven foreign countries. Outside of Illinois, Indiana sent the largest delegation, with Wisconsin second, Ohio third, and Iowa fourth.

The exhibits covered 6,000 square feet, more than ever before, one hundred and fifty firms, with an average of five representatives, each, occupying space.

THREE MILLION DOLLAR GIFT

Provides Building for Northwestern University Dental School

Three million dollars given by Mrs. A. Montgomery Ward to Northwestern University, for the construction of a large Dental-Medical Center upon the new urban campus at Lake Shore Drive and Chicago Avenue, will provide for the Dental School quarters for five hundred undergraduate and one hundred graduate students in dentistry in a building of the most modern design.



FREE COMMUNITY DENTAL SERVICE

Children's Free Dental Clinic

The opening of the children's free dental clinic at Cook County hospital Nov. 21, marked a milestone gained for the Chicago Dental Society who have worked for 20 years to see free community dental service established in Chicago.

The opening was a big affair, attended by a large body of the city's ethical dentists and by many prominent welfare workers. The Visiting Nurses' Association, the Woman's City Club, League of Cook County Clubs, the Board of Education and the Juvenile Court sent delegates.

The clinic has done splendid work since its opening, Nov. 21. An average of 42 children a day have received treatment and seven operators are working full time.

First, the topics for the two general sessions were considered and "Community Dental Service" was selected as the key note of the meeting, this being a timely subject, of interest to every progressive dentist and of vital importance to the entire community as well.

ACCESS TO CARE

A look at challenges facing our profession

‘Every time I leave I feel like I did something okay’

Orthodontist brushes up on his general dentistry skills to volunteer at Willow Creek Community Church Care Center

It had been a long time since Michael Hayward performed general dentistry.

And though the Barrington orthodontist sold his practice a few years ago, the Chicago Dental Society member called on those skills again when he began volunteering at a new dental clinic which is part of the Willow Creek Community Church Care Center. The clinic opened June 3.

“I’m an orthodontist, so dentistry is a little foreign to me,” said Dr. Hayward, who has been a member of Willow Creek Community Church, South Barrington, for 38 years.

Dr. Hayward, however, was able to revive his general dentistry skills during a mission trip to Guatemala, which included Dr. James Cho; Nancy Colovos, Health Services coordinator at Willow Creek Community Church; Dave Cimo, program manager for health services at the Care Center; and a registered nurse.

“Not being familiar with some of the restorative materials being used today, I found myself primarily scheduled to treat patients requiring extractions. I received a good review course before I went to Guatemala from some very good friends

who are oral surgeons; they gave me an intensive four-day review course on how to extract teeth,” he recalled. “In Guatemala, Nancy was my assistant. She said, ‘Mike, you’re pretty good at that.’ She’s kind of plugged me into the oral surgery spot (at the dental clinic) because we don’t have an oral surgeon there.”

The dental clinic is open Mondays, Wednesdays, Thursdays, Fridays and some Saturdays; Dr. Hayward works two to three Fridays a month. Services are limited to oral exams and X-rays, cleanings, restorative services, minor tooth extraction and oral health education. Patients pay \$20 per visit. The clinic provided \$205,438 in dental services in 522 dental visits in its first six months.

“I think what we’re trying to do is provide a service to the under-resourced,” said Dr. Hayward. “There are people who are struggling to make ends meet, whether unemployed or just facing hard times. They have had to decide to defer their oral care. That’s who we serve. It’s very sad. It’s nice that we’re at least providing some help for them. We’re just trying to avoid their oral care from being neglected, and help them get on their feet a little bit.

“Some of the folks don’t have transportation. I’ve worked on several people

who were homeless and have been invited by others to come to the clinic for assistance.”

The experience has been rewarding for Dr. Hayward, who admits that he had always wanted to do volunteer work but just didn’t have the time until he sold his practice. His wife, Barbara, intervened.

“My wife was concerned that her husband had something better to do with his extra time, so she said, ‘you know, you could work at the Care Center,’” said Dr. Hayward, one of 17 dentists who volunteer at the dental clinic. The clinic also has 17 hygienists and 45 other volunteers.

“Every time I leave I feel like I did something okay,” he said. “I’m an orthodontist. I live in a nice community. I am able to travel and live a very comfortable life. It’s nice to help other people who don’t have those advantages and probably never will.

“It’s nice that most of them are gracious and say ‘thank you.’ That’s all I get back. I don’t need to get anything else.” ■

GE Capital Retail Bank to refund \$34.1 million

CFPB ANNOUNCES SETTLEMENT AFTER INVESTIGATION REPORTS CARECREDIT CARDS MISLED CUSTOMERS

General Electric Co.'s credit card division will refund \$34.1 million to consumers who government regulators say were misled about the potential costs of relying on a deferred-interest plan to pay their medical bills.

The settlement, announced in December by the Consumer Financial Protection Bureau (CFPB), affects more than 1 million people who obtained CareCredit cards from GE Capital Retail Bank since 2009.

GE Capital didn't acknowledge any wrongdoing in consenting to the order.

Regulators contend that GE Capital Retail Bank exploited consumers by not taking adequate steps to ensure they understood the terms of the credit cards that they obtained to help cover the costs at doctors' and dentists' offices around the country.

In many instances, health-care providers told patients that the CareCredit cards would provide interest-free financing for a year, according to regulators. But the charges could only be avoided if the entire amount was paid within a year after the charge. If an outstanding balance remained at the end of the one-year grace period, interest accruing at a rate of nearly 27 percent was then tacked on to the bill.

"Medical debt is already a big problem for many Ameri-

The chief of the hospital dental service is responsible for all oral healthcare provided in the University of Illinois Hospital and Health Sciences System. Some of the responsibilities include the appointment and re-appointment of College of Dentistry faculty to hospital staff, review of quality assurance of patient care provided by residents and attending staff, and service on the Medical Staff Executive Committee.

Dr. Miloro said he is highly motivated to serve in this role and build on Dr. Punwani's accomplishments.

"Currently, we have 23 faculty members in four College of Dentistry departments (including Oral and Maxillofacial Surgery, Pediatric Dentistry, Orthodontics, and Oral Medicine and Diagnostic Sciences) with medical staff privileges at UI Health," said Dr. Miloro, "and the specific departmental privileges will need a current update with the changes in health care and expanded scope of clinical practice. We have a large and diverse group of College of Dentistry clinicians on the medical staff at UI Health, and it is my role to reinforce, and further heighten awareness of, the vital importance of oral health care within the medical center environment within the context of individualized patient care.

"I would like to bridge the gap between Taylor and Paulina streets such that oral health care is readily accessible to the UI Health medical center physicians, staff, and patients for both urgent and non-urgent situations, and for continuity of patient care," Dr. Miloro continued. "Many medical centers across the country struggle to find dental and oral health care services for their inpatient and outpatient population, and we are in the unique position here at the University of Illinois at Chicago to provide these acute, as well as on-going, multi-disciplinary services to our own medical center."

cans," said CFPB director Richard Corday, in a statement. "Poor credit card transparency should not be making the problem even worse."

GE Capital Retail Bank spokeswoman Dori Abel said CareCredit has one of the highest customer satisfaction levels in the industry, with about 60 percent of customers deciding to charge additional bills on their cards. CareCredit agreed in June to provide more infor-

mation about its deferred-interest plans as part of a settlement reached with New York Attorney General Eric Schneiderman.

Under the *Dodd-Frank Wall Street Reform and Consumer Protection Act*, the CFPB has the authority to take action against institutions engaging in unfair and deceptive practices. To ensure that consumers harmed by such practices are appropriately compensated, and that consumers are no

longer subject to these unfair practices, the CFPB order requires that GE Capital Retail Bank and CareCredit:

- **Create a \$34.1 million reimbursement fund.** Consumers who incurred charges in connection with their credit cards will be notified by CareCredit that they may file a claim seeking reimbursement.

Claims will be reviewed by an independent adjudicator. More than 1.2 million consumers will have access

to this independent review process and the reimbursement fund.

The company will pay all expenses related to the administration of the fund.

- **Enhance consumer disclosures.** CareCredit will also be required to enhance the disclosures provided to consumers during the application process and on billing statements.

The new disclosures will include improved descriptions of the deferred-interest product, and consumers will be warned in advance when the promotional period is ending.

Representatives will contact most CareCredit consumers within 72 hours of the initial transaction to explain the product to them

over the phone.

In addition, for certain transactions of more than \$1,000, consumers will enroll directly through a CareCredit representative and not through the doctor or dentist's office representative.

- **Improve consumer experience with service providers.** CareCredit providers will be required to follow new transparency principles, including mandatory training for staff who market the CareCredit card to consumers. They will also be required to provide plain-language disclosure forms to ensure that consumers receive adequate information before signing up for a card.

Frederick Orendach

and bones named Sue

As a child, Frederick Orendach would hop on the “L” in the Englewood neighborhood and ride it to visit Chicago’s many museums.

“It was a thing of wonder,” he said of those childhood visits.

For the last four years, Dr. Orendach of Burr Ridge, alongside his wife, Marie, has volunteered between 200 and 250 hours annually at The Field Museum of Chicago, mostly on Sundays.

“I love it. You meet lots of interesting people,” he said. Among them he named primate authority Jane Goodall and Sue Henrickson, who discovered the dinosaur at the center of the Field Museum’s SUE exhibit. It is the largest *Tyrannosaurus rex* skeleton yet found.

Along with meeting experts, he also enjoys interacting with museum visitors.

“I love to see families with kids and teenagers coming in,” he said. “They have so much wonder.”

Dr. Orendach, now the West Side Branch president, said he was first inspired to volunteer years ago when his daughter Alison, then 12, volunteered at the museum with Marie, who has been doing the same for 20 years. But with a busy dental practice, he put that plan on hold.

So it was four years ago, with his love for the city’s museums riding high and his Englewood dental practice slowing down, that Dr. Orendach thought it the perfect time to join his wife in her volunteer post.



“It (fewer hours in practice) gives me time to give back what I was given as a kid,” he said. “Not a day goes by that I don’t pick up one or two new things.”

As a volunteer, Dr. Orendach often leads tours of the museum; he especially enjoys focusing on traveling exhibits. He noted the museum trains its volunteers well so that they are knowledgeable of the exhibits and can answer visitors’ questions.

Some of his favorites are an ecological restoration exhibit as well as traveling exhibits on China, Cleopatra and King Tut. He noted that the museum’s initial exhibit of the King Tut artifacts in 1973 prompted his membership to The Field.

“The museum is so, so diverse,” he said. “It covers so much of everything.”

A 1967 graduate of the Loyola School of Dentistry and a St. Rita High School alum, Dr. Orendach is as proud of his hometown as he is the museum.

“Chicago is the nicest city in the whole darn world,” he said. “It has the cleanest streets, a diverse culture, and the nicest people. I wish I could volunteer at every museum.”

In addition to The Field, Dr. Orendach enjoys visiting the Museum of Science and Industry — a childhood favorite — as well as the Chicago Historical Society and the Chinese American Museum in Chinatown.

Dr. Orendach currently sees patients — some of whom he has treated for 40 years — two to three days a week. Whenever he decides to retire, increasing his volunteer hours is near the top of his list of priorities, he said.

“If I ever retire, I’d like to add more (volunteer) days,” he said. “I get more out of it than I put into it. It’s fun.” ■

There is a silent revolution occurring in dental education; it is unorganized, uncoordinated and disparate. It has one common thread, which is offering a variant on the medical model of education. The concept is not new; the founders of this country's dental schools in the 1880s debated whether dentistry should be a specialty of medicine.

In 2015, the University of Illinois at Chicago College of Dentistry will confer a Doctor of Medicine in Dentistry (DMD) degree for the first time to its graduating class. The change from the traditional Doctor of Dental Surgery (DDS) to DMD reflects the school's new philosophy of treating a patient for all their dental needs by one student, rather than viewing the patient as a required clinical procedure. I think awarding a DMD degree is a logical evolution of dental education. It's a seemingly modest change, but with profound effects.

Oral Maxillofacial Surgeon (OMS) graduate programs have long offered dual degrees in medicine with a certificate in OMS.

Case Western Reserve University Dental School is offering a DMD/MD after completion of a five-year program that integrates both disciplines. Applicants for the program have to be highly motivated and excellent students, especially in the sciences.

The Harvard School of Dental Medicine (HSDM) has kicked it up a notch by offering an Oral Physician (OP) residency. The program, co-sponsored by Harvard Medical School and the Cambridge Health Alliance of Massachusetts, would add a year to a general practice residency.

HSDM faculty members Donald Giddon, DMD, PhD, and Brian Swann, DDS, PhD, assert that by "... increasing numbers of mid-level providers, particularly in underserved areas, patients will not be willing and able to distinguish these non-dentists from more highly trained dentists." Dr. Giddon goes on to say in a DrBicuspid.com news article, "Dentists, therefore, must assume a new superordinate designation as oral physicians who will oversee all dental care, whether provided by a dentist, or non-dentist, including physicians."

Dr. Giddon, a Fulbright scholar, is a distinguished educator, scientist and former dean. He has been promoting the creation

of an OP designation for nearly a decade; he finally convinced Harvard to offer the program three years ago. I think his planning assumptions were flawed.

First, the number of mid-level providers is not increasing and certainly if created they would not clamor to go to underserved areas. Canada has had dental therapists since 1978. However, many are migrating back to cities where making a living wage working for a dentist is paramount.

Secondly, the creation of the newfangled OP term is itself confusing.

No, Dr. Giddon's well-meaning quest for a different type of dental practitioner is riddled with real problems. Not the least of the unanswered questions is where would they work, what would they do, and who would pay them? He has identified a problem that doesn't exist and then applied a solution.

It appears that Dr. Giddon did not read *The Harvard Business Review* article, "Are You Solving the Right Problem?" by Dwayne Spradin in which he avers, "... most companies (organizations) are not rigorous in defining the problems they are attempting to solve."

I believe the underlying thrust of these changes in dental education is that we are moving toward a fifth year of dental school. Is that the problem or the solution?

Albert Einstein told us, "If I were given one hour to save the planet, I would spend 59 minutes defining the problem and one minute solving it." ■
