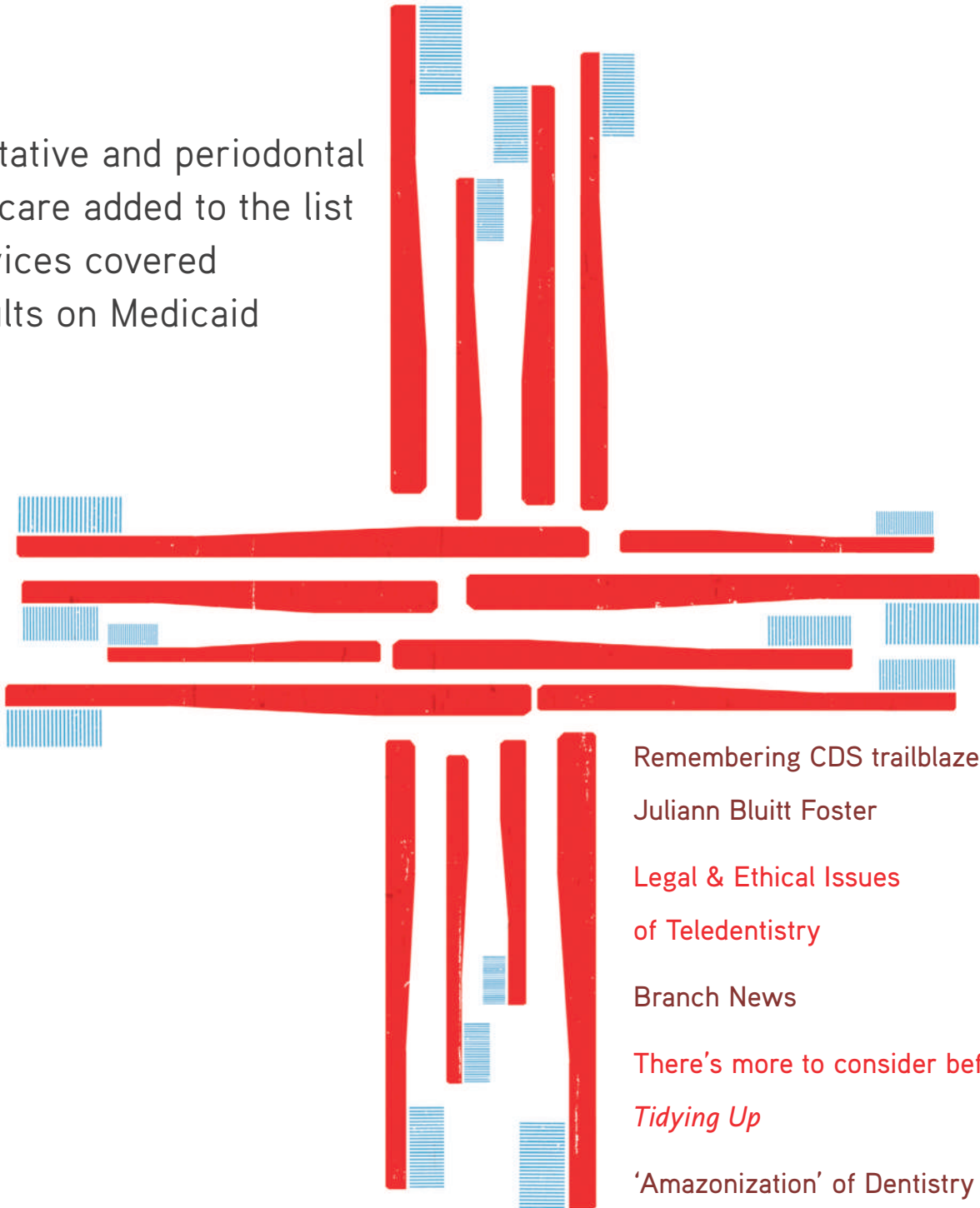

Lifetime Achievement Award

The Lifetime Achievement Award recognizes longstanding members who dedicated much of their professional career to the advancement of ISDS.

"For decades, these extraordinary members have repeatedly volunteered time and effort serving for the betterment of the society. Any member may nominate an active, life, retired life or retired member for this award by completing a nomination form," ISDS states on its website.

Last year's recipient of the lifetime award was Milton Salzer. CDS Review Editor Walter Lamacki was the recipient in 2016.

Distinguished Member Award

Another annual ISDS honor is the Distinguished Member Award given to a member dentist.

"This award is bestowed on a colleague who, over the years, has tirelessly made significant contributions to the service of

mankind extending the profession of dentistry into civic, cultural, religious, and humanitarian areas. This award recognizes a member who has exceeded the ordinary with outstanding contributions, thus enhancing the image of organized dentistry," ISDS says in a description of the award.

The first distinguished service award was presented to Edwin Dale in 1989. Joseph Hagenbruch was the recipient in 2018.

Humanitarian Award

In 2016, ISDS instituted a Humanitarian Award recognizing member dentists who have given at least 10 years to improving the oral health of underserved populations in the United States and/or abroad. The award includes a \$500 donation to the dental charity or project of the recipient's choice. Nominate one active, life or retired ISDS member in good standing per year by submitting a nomination form to the ISDS Humanitarian Award by the deadline. Sharon Perlman was the recipient of this award last year.

Do we have time for prevention?

EACH WEEK IN MY OFFICE, I AM BLESSED TO BE ABLE TO MEET AND TREAT NEW PATIENTS.

Just like most of you, on my very first encounter with a patient, I introduce myself and discuss the patient's primary concerns and the desired outcome for their visit. In the majority of cases, the reason for the patient's visit is unfortunately pain.

Perhaps even more unfortunate is the rarity in which patients experiencing pain tell me that the issue started last week or yesterday. Rather the story usually is, "I started having a little discomfort several months ago but now it's constant."

Even after 32 years of practicing dentistry my face can't help but show dismay and disappointment that the patient didn't come in sooner. I express my empathy and proceed to review their dental and medical history to make the best possible plan of action for their treatment.

During discussion of their dental history, I find out that the majority of patients only brush their teeth once per day, usually in the morning before breakfast, and that the majority of patients like to use a medium bristled toothbrush, both are problematic.

Then when I review their X-rays, they often reveal interproximal decay in the posterior region. It has also become commonplace for me to find that the patient has additional interproximal decay and/or possibly missing posterior teeth.

With these patients I always take time to inquire about their diet, specifically their snacking habits. I often start by asking, "Do you suck on peppermints or mints?"

It's not unusual to hear: "How did you know? I have a big bag in my car."

For those who answer "no," I've found that unless I expressed the exact name of the offending "mint," these patients will maintain that they do not actively consume treats.

Over time, I started asking, "Do you use peppermints, Mentos, Tic Tacs, Altoids, Life Savers, cough drops, lozenges or hard candy of any kind?"

"Yes," is the usual response.

Most patients do not realize that all of those things are mostly sugar and should be considered candy. They don't realize that using "breath mints," even occasionally, is the cause of long-term decay over time, resulting in the systematic loss of teeth. I know many of you reading this are thinking the act of creating and facilitating this type of dialogue with our patients is time consuming.

However, I've noticed that taking this time to educate patients is always greatly appreciated by the patients as well as necessary. If we do not take the time to educate our patients then we cannot advocate for decay prevention.

Prevention is more than just telling a patient to eat right and brush after every meal. Sometimes it means taking time to analyze what the patient is doing that is causing their poor oral health.

Whether you choose to properly train staff members to do this or to handle each patient's case personally, it is our duty to instill the steps and knowledge of prevention in our patients.

We have to do a better job educating our communities that brushing with a medium toothbrush in the morning before breakfast and sucking on mints to freshen their breath throughout the day is not the way to prevent dental decay.

I know that our patients have many misconceptions about oral health; the use of hard candy is just one example.

It seems to me we need a concerted large-scale public oral health campaign on prevention and how oral health affects overall health.

Until we have such a program, I hope you will take the time for prevention education in your practice. ■

Juliann S. Bluitt Foster

CDS President 1992-93

The first female president of the Chicago Dental Society

JULIANN BLUITT FOSTER, THE FIRST FEMALE PRESIDENT OF THE CHICAGO DENTAL SOCIETY, died April 17 in South Carolina, where she had moved following retiring from dentistry.

She was the only child born to Marion Eugenia Hughes and Stephen Bernard Bluitt on June 14, 1938, in Washington, DC.

A 1992 *CDS Review* profile of Dr. Bluitt Foster described her as an author, speaker and tireless advocate of organized dentistry, who was inducted into the Chicago Women's Hall of Fame in 1991 in recognition of her involvement in dental care and dental education in the city.

Dr. Bluitt Foster was an ardent supporter of CDS and traveled to Chicago this past February to attend the 154th CDS Midwinter Meeting at McCormick Place West. She was instrumental in moving the 127th Midwinter Meeting to the larger location at the McCormick Place Lakeside Center while serving as CDS president in 1992-93.

The move boosted meeting attendance, attracting dental professionals from throughout the country and world.

In 1993, after serving all elected offices, she was elected the first female and African-American person to become president of the American College of Dentists, the honorary dental society, taking office in Las Vegas in 1994.

As the first female president in these



two organizations it was an accomplishment and challenge she readily accepted. Through it all, her husband, Roscoe Foster, a practicing orthodontist, accepted and participated as “first spouse.”

Dr. Bluitt Foster was the subject of numerous news articles and feature stories including in the pages of the *Chicago Tribune*, *Today's Chicago Woman*,

Chicago Sun-Times, *Ebony* magazine and *Jet* magazine as well as being featured in many national and local radio and television programs.

Most recently she was highlighted with a front-page profile in the April 2019 issue of the *Illinois Dental News*.

Dr. Bluitt Foster was actively involved in CDS, serving as Kenwood/Hyde Park Branch Director in 1981 to 1984. She

also served as the branch's president in 1985-86 as well as stints as secretary and vice president. She served on several CDS Midwinter Meeting committees including chairing the Course Division Committee in 2002, as well as serving on the Reception Committee on Visiting Women Dentists from 1979-82; the Ladies Hospitality Suite in 1979-80; and the VIP Reception Committee as co-chair in 1989-90 and as past-president from 1993-96. She served on several CDS standing committees as well, serving on the Health Systems Agency Liaison Committee in 1983-84; the Dental Health Education Committee from 1984-87, including as chair the last term; the Special Events Committee from 1986-90, acting as chair the last term, and on the Monthly Meeting Program Committee from 1986-89. She served on the CDS special Permanent Investment Committee in 1988-89. She also served on numerous branch committees between 1975 and 2000 and was an Illinois State Dental Society delegate /alternate from 1987-93.

Dr. Bluitt Foster was educated in the public schools of Washington, DC, where her mother was a well-respected and accomplished first-grade teacher.

She attended Howard University, Washington, DC, where she earned a Bachelor of Science Degree in Zoology in three years. She entered dental school as one of a small number of women in the profession in 1958 and graduated Cum Laude at the age of 23.

Following graduation, she was hired to teach at the Howard University College of Dentistry in the Department of Oral Medicine. She left after one year moving to Chicago to assume a position with the Chicago Board of Health where she remained for five years. In 1967, Dr. Bluitt Foster joined the faculty of

Northwestern University Dental School as chair of the Dental Hygiene Department.

With students from all over the United States attending its program, Northwestern sustained and grew as a premier program for students who chose to enter the profession. From her guidance, counseling and mentoring, over the years, an impressive number of students went on to pursue dental degrees.

In her career at Northwestern, Dr. Bluitt Foster served in several capacities including assistant dean of community affairs, assistant dean of admissions and student affairs and associate dean of student affairs.

Her expertise and experience, also allowed her to be solicited to participate in committees on the national level in organized dentistry and in professional affiliate groups. She served on the National Advisory Council for Health Manpower Legislation, on the Federal Drug Administration Committee, and the Advisory Council to the Director of the National Institutes of Health in Bethesda, MD. As a committee member for a number of years in each of these capacities, she was known for her outspokenness and diligence. Her proudest accomplishments were serving on the committees which authorized mapping of the Human Genome and the investigative study for this newly emerging disease, Acquired Immune Deficiency Syndrome or AIDS.

Dr. Bluitt Foster was well respected by her colleagues both professionally and personally.

"Dr. Juliann Bluitt was an amazingly accomplished professional. She dedicated her adult life to the education of others in the dental profession," said CDS President Cheryl Watson-Lowry, the second female African American CDS

president. "As the first female and African-American female president of the Chicago Dental Society, Juliann Bluitt inspired me and countless others to pursue our dreams without limitation. She not only served as a role model to so many of us but was also a pioneer in multiple arenas. I was blessed to be able to spend some time with her at this last Midwinter Meeting. I will forever be grateful for those moments."

In the ISDS profile, 1991-92 CDS President William Kort, her immediate predecessor, was quoted as saying Dr. Bluitt Foster and her late husband, Roscoe, were "delightful friends" who were "fun, kind, compassionate and over flowingly generous."

"While serving on the CDS Board with Juliann, no one was more dedicated or prepared; her work was consistently superior, insightful and nothing short of profound excellence. I loved working with her and will always immensely value her friendship," Dr. Kort was quoted as saying.

Dr. Bluitt Foster did not slow down after retiring 17 years ago. After moving to Hilton Head Island, SC, with her husband, she involved herself with various interests and community activities

She was active in the local Meals on Wheels, was a member of her home community association's board of directors and a board member of an art league, and the Women Philanthropy Society.

She was also an artist and author, producing the *Hector and Timmy Coloring Book*, intended to motivate children to be active participants in their oral health.

With her husband she enjoyed travel and experienced many venues both in the United States and internationally. They especially enjoyed their African safaris and travels to South America,

Mexico, and other more undeveloped countries. She kept up the spirit of travel and ventured abroad to Spain, Portugal, Paris, London, Vietnam, Thailand and Cambodia and other places on her own after his death in 2014.

She and Roscoe were married 41 years. She is survived by Roscoe's adopted son and daughter, David and Barbara Foster, three grandchildren, and one great-grandchild.

A Mass of Christian Burial was held April 24 at St. Francis by the Sea Catholic Church in Hilton Head. Interment followed in Six Oaks.

I met Juliann Bluit Foster sometime in 1980 and was immediately captivated by her melodious voice; I'm not a musicologist, but I would say she was a contralto fit to sing *Carmen*.

Serving on several committees together, I was impressed by her intelligence and especially her vast vocabulary, pronouncing words I feared to utter, lest I mispronounced them.

She served on the CDS Board of Directors and in all the offices of the society, culminating in the presidency in 1992-93, the first woman president of CDS.

She nominated me for president-elect of the ADA at the ISDS House of Delegates with rip-snorting speech. It made me think, "Is she talking about me?"

We also served together on a search committee to find an executive director for CDS.

At one meeting with a prospective candidate for the position, she asked a rambling, convoluted question with many multisyllabic words that kind of confused the committee; of course, the question puzzled the candidate. Our chairman was past president CDS William Slavin.

He turned to the aspirant, whose forehead was somewhat crinkled, and translated for Dr. Bluit Foster.

Dr. Slavin said: "She wants to know how much you want to make?"

Everybody roared in laughter, but her laughter drowned out everyone else in the room.

That's the wonderful self-effacing person we all loved.

A positive move for Medicaid

preventative and periodontal dental care added to the list of services covered for adults on Medicaid

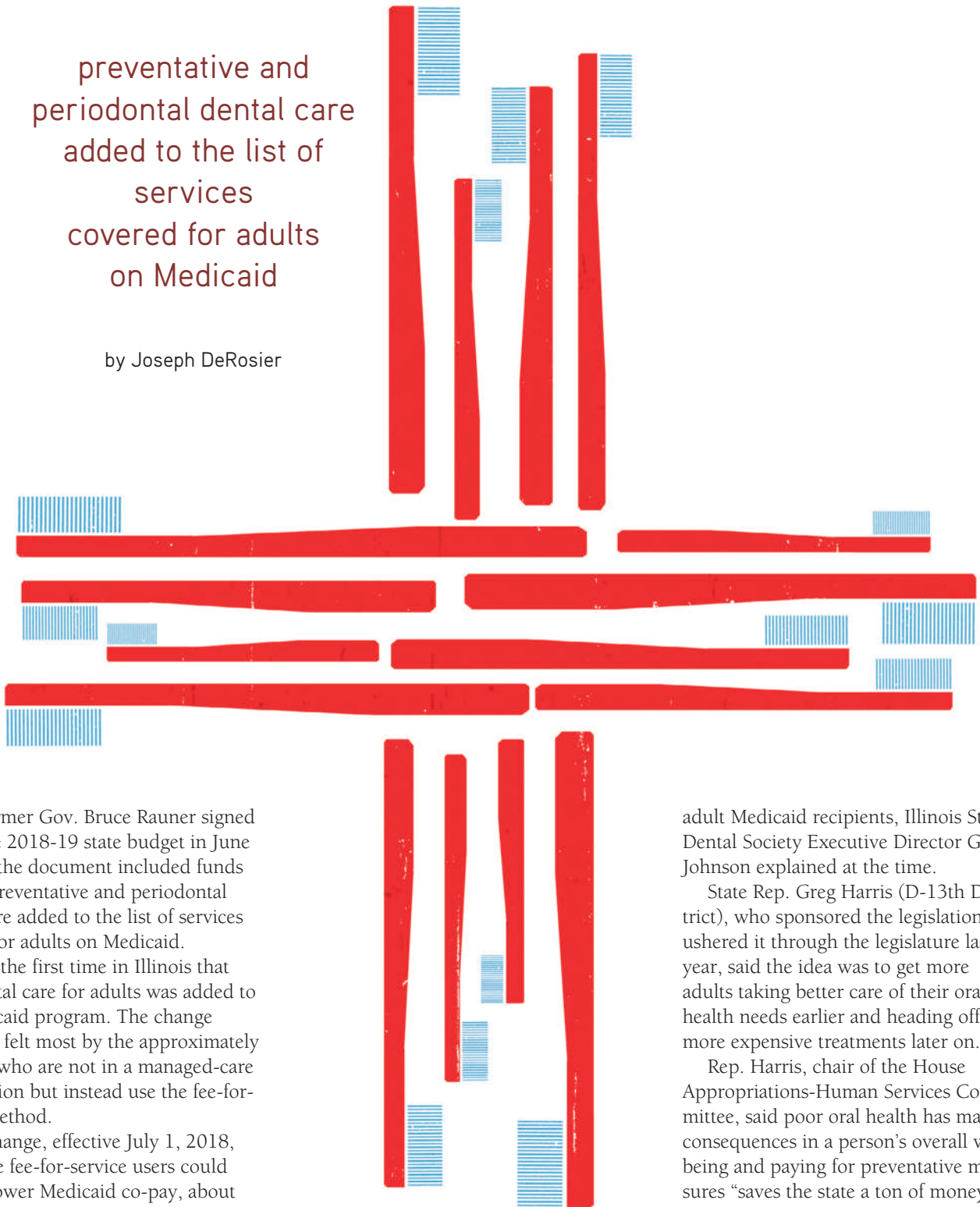

When former Gov. Bruce Rauner signed off on the 2018-19 state budget in June of 2018, the document included funds to have preventative and periodontal dental care added to the list of services covered for adults on Medicaid.

It was the first time in Illinois that such dental care for adults was added to the Medicaid program. The change would be felt most by the approximately 450,000 who are not in a managed-care organization but instead use the fee-for-service method.

The change, effective July 1, 2018, meant the fee-for-service users could pay the lower Medicaid co-pay, about \$4, for dental exams and cleanings rather than the more expensive out-of-pocket amount.

It also benefited the MCOs that would now be reimbursed for the coverage; the MCOs had voluntarily covered

adult Medicaid recipients, Illinois State Dental Society Executive Director Greg Johnson explained at the time.

State Rep. Greg Harris (D-13th District), who sponsored the legislation and ushered it through the legislature last year, said the idea was to get more adults taking better care of their oral health needs earlier and heading off more expensive treatments later on.

Rep. Harris, chair of the House Appropriations-Human Services Committee, said poor oral health has major consequences in a person's overall well being and paying for preventative measures "saves the state a ton of money."

John Hoffman, director of communications and public affairs for the state's Department of Healthcare and Family Services, which administers the Medicaid program, said the funding is carried forward into the next fiscal year.

Usage numbers are not available since the coverage has been in effect for less than a year, he said.

But Jason Grinter, a general dentist from Rockford who handles a number of Medicaid patients and serves on the CDS Government Affairs and Access Advocacy Committee, said he thinks the added coverage is working well.

"I'm happy about it as a dentist, and they are happy about it as patients," Dr. Grinter said of the new coverage.

The initial publicity about the change, he added, focused on the preventive care aspect. But, he pointed out, it also includes coverage of periodontal procedures such as root planing and scaling. He said that is having a major impact.

"For far too long, we have always had to skip those parts, and it was either the patient was unwilling (to be treated) or unable to get treatment because his insurance didn't cover it," Dr. Grinter said. "That's certainly understandable considering out-of-pocket costs can be pretty hefty for a periodontal therapy."

He said adding periodontal therapy means dentists can work on keeping the patient's gums healthy and keep periodontal disease at bay.

"In the short term, we're going to see a lot of benefits," Dr. Grinter said. "But really, we're going to see a lot more (benefits) in the long term when patients are holding on to their teeth longer and the overall health of their mouth is much better."

He said attacking gum disease issues early means better patient care.

"From there we can do things like restorative care, fabricate partial dentures, etc.," he said. "It's allowing us to actually follow the correct sequence of treatment for a change, which is nice."

And that means that the work dentists do will last longer and serve the patient better, he said.

Dr. Grinter said he thinks Illinois adults on Medicaid had a "pretty decent set of comprehensive dental benefits" even before the change when compared to some neighboring states, but the change elevates the level of care more.

"With the addition of preventative routine cleanings and the periodontal therapy, we're really able to focus on so

much more than restoring teeth that do not have a solid foundation because there was no routine cleanings being done," he said. "From a dental perspective, it's really kind of exciting, especially for a population that really needs it the most."

Another part of the legislation called for reimbursement to dentists for treating adults to be the same rate dentists receive for treating minors.

Even with the higher rates, Genaro Romo, a Chicago dentist who works with many in the underserved community, said more changes to Medicaid are needed.

"In my office I made a conscious effort to not see adults with Medicaid," Dr. Romo, a member of the CDS government affairs committee, said. "I called Medicaid and told them I'm just not happy with a lot of things with Medicaid and I wanted to close my enrollment with adults."

He said he continues to see current Medicaid patients, who are mostly children.

He said reimbursement rates for dental cleanings for adults is \$41, the same as for children.

"Here's the problem with the \$41," Dr. Romo explained. "The average (pay) range (for hygienists) is from \$37 to \$45 and up an hour, if we're getting paid \$41 for a cleaning and if I'm paying my hygienist \$37 an hour, I'm making \$4 in profit. And that doesn't cover the disposables I use, the time, it's just not cost effective."

And while it is a plus that Medicaid now covers periodontal work of root planning and scaling, Dr. Romo said his experience of the process of getting Medicaid approval for the procedures can be summed up in one word, "horrible."

"It takes a lot of time, a lot of effort headaches, a lot of calling to them, and there are always issues of X-rays being lost that we sent to them," Dr. Romo said.

"For me, I've been taking Medicaid for 22 years, I am one of those people who have thrown in the towel and said, 'I've had it with this; I'm not going to take it, especially with adults, because it is such a big hassle.'"

He said he refers adult Medicaid

patients to other dentists he knows will take them.

And even though reimbursement per quadrant for periodontal work is \$122, it is still not enough to compensate for all the hoops that must be jumped through and the approval delay involved, which can take weeks, he said.

Plus Medicaid fees have stagnated for much of the time he has been a participant.

"It has become increasingly difficult to be able to pay my staff, pay the bills and the property taxes and mortgage and things like that because the reimbursement is way, way too low," he said.

"Dentists don't like talking about this in public because it makes us sound like that's all we are after, but the reality is that enough is enough; we need a whole Medicaid reform. That's really what should happen, somebody needs to take a deep look into it and see what we can do because it's affecting access to care.

"I'm glad that we got them to pay the \$41 for cleaning; it's better than zero or turning people away. But what kind of an effect do you think it will produce?" he said.

He said he didn't think the new law will mean there will be a huge increase in dentists signing up to be Medicaid providers.

Dr. Grinter said, however, that he thinks the changes may mean less frustration for dentists trying to create a dental care plan for Medicaid patients.

"I am seeing offices that for many years haven't focused on adults and are now opening more time slots for adult appointments," he said.

"Now we can take a whole new approach and can treat the mouth, which will treat the body and really move forward, and patients are definitely getting more care in offices than they would have had in the past," he said.

Overall the change is nothing but a plus, Dr. Grinter said.

"I think in the long term we will see benefits from it. We will see patients happier, healthier and keeping their teeth longer and coming in more frequently," he said. ■

There's more for your dental practice to consider before *Tidying Up*

If your home has been swept up in the decluttering wave, you are not alone. Based on Marie Kondo's 2014 book *The Life-Changing Magic of Tidying Up* and the subsequent 2019 Netflix series *Tidying Up*, millions of people are learning to live with less. They are purging their closets of unwanted clutter.

But be warned: Ms. Kondo's method best not be applied to your dental office. Government regulations and professional responsibility demand that you purge your office far more deliberately than Ms. Kondo teaches in her book.

The so-called KonMari Method dictates that you move through your home sorting categories of items – clothing, books, papers, and so on – and identify which items spark joy. Those things that don't are sorted into containers for trash, recycling and donations.

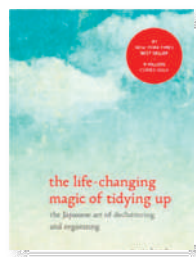
The charitable organizations that collect our discarded items for reuse by others are benefitting tremendously from our home-based efforts. Goodwill

stores across the country are reporting increases in donations ranging from 22 percent in Houston to 3 percent in Tampa.

Chicago area-based WINGS resale shops recently reported a 40 percent increase in donations, with sales benefitting local victims of domestic violence.

But your dental office isn't like your home office, and your supply closet has few similarities to your kitchen pantry. Illinois State Dental Society Director of Government Relations Dave Marsh said it is the responsibility of the dentist to seek out the local ordinances and federal regulations that govern decluttering activities in your workplace.

"There are EPA (Environmental Protection Agency) guidelines and OSHA (Occupational Safety and Health Administration) requirements and state requirements and local ordinances that you need to be aware of," Mr. Marsh said. As a reminder of how different the laws can be, he explained that in Chicago it is prohibited to return extracted teeth to a

it is allowed in other parts of Illinois.

The best resource for a responsible dentist, he advised, is the American Dental Association's member handbook.

An ADA spokesperson directed me to the online Center for Professional Success. The Guidelines for Practice Success, a password-protected page for ADA members, includes several articles on managing professional risk. These range from issues of consent to HIPAA enforcement, but skimming the table of contents also yields resources for regulatory agencies (including a lengthy discussion and several links to www.epa.gov for further information on the disposal of pharmaceutical waste and hazardous waste pharmaceuticals); further down you'll find advice on record destruction and the retention of other business records.

When the item you seek to dispose of is electronic equipment, Mr. Marsh said the recommended action is often dictated by the features of the machine. Having the owner's manual in hand, when you access the government regulations, will be helpful.

"And if items are disposed of improperly, you're responsible," Mr. Marsh said. "It's on you to act properly."

For items not regulated by government policies – things like fax machines and copiers – your local government can still be a good resource for responsible disposal. The Solid Waste Agency of Northern Cook County maintains a list online of local companies and charitable organizations that will haul away or accept for recycling various common office machines. ■

Teledentistry legal, ethical issues are numerous

TELEDENTISTRY, IN WHICH THE DENTIST IS IN ONE LOCATION AND THE PATIENT ANOTHER, IS A DEVELOPING AND BENEFICIAL FORUM TO provide dental care to those who are unable to be treated at your office. It is also used to provide care in underserved communities throughout the country.

However, teledentistry must be used judiciously and has limitations.

A bill, which defines teledentistry, is making its way through the Illinois General Assembly. The bill states: "The use of telehealth systems and methodologies in dentistry and includes patient care and education delivery using synchronous and asynchronous communications under a dentist's authority as provided under this Act."

Synchronous teledentistry is "live" delivery of dental care via two-way interaction between the patient and dentist who are in different locations. An example is a dentist using FaceTime to treat a patient in real time who just sustained fractures of Teeth Nos. 8 and 9 in a bicycle accident. In fact, the ADA has a CDT code (D9995), which may allow a dentist to charge insurance for such an encounter.

Asynchronous teledentistry is CDT code (D9996), which is not real time, but rather, provides for the transmission (via email) of dental health information (i.e. radiographs, photographs, digital impressions, etc.), allowing the dental professional to examine this information to make a diagnosis. In other words, examining an X-ray with a large radiolucency over Tooth #13 on a patient with a history of upper left pain may lead to a diagnosis of apical periodontitis and the need for root canal therapy.

Teledentistry also raises interesting legal scenarios, including whether an Illinois dentist on vacation in Florida can practice teledentistry on his patient back home.

The laws for teledentistry throughout the United States are emerging with many states not yet with statutes governing this type of dental healthcare delivery. However, state laws will eventually require that dental offices have set protocols in providing dental services remotely which may likely include the following:

- Require that the patients already be “a patient of record” so as to allow the dentist to access, via computer, a patient’s record;
- Require the dentist to provide the risks and benefits of teledentistry, including its limitations. For instance, a patient with vague lower left jaw pain with no associated swelling may be impossible to diagnose via teledentistry;
- Educate the patient and dentist as to the “abuses” that teledentistry can lead to such as discouraging (or encouraging) a patient to not come to the office for treatment.

Dental professionals need to check with their malpractice carrier to see if it provides coverage for teledentistry.

Teledentistry also raises interesting legal scenarios, including whether an Illinois dentist on vacation in Florida can practice teledentistry on his patient back home. It could be argued that under Florida law he is practicing dentistry without a Florida dental license.

Despite the many legal and ethical issues, teledentistry will certainly be more utilized in the near future in order to provide more access to a dentist’s expertise and treatment, which, in the end, will be beneficial to many. ■
